7/3/2025	No	5	Adamant	Dear Town of Hampden,First of all, I would like to thank the Hampden town board for taking into consideration the opinions of the people/taxpayers that will be negatively impacted should this proposal for wind energy be granted. I have taken considerable time to look into these projects and so far, the only information I have found to be consistent throughout gives me cause for great concern. I have listened to the people who represent the companies and on multiple occasions when representatives are asked questions, by either myself or other citizens, the vague answers they give, or by not answering the questions at all, have convinced me that there are negative consequences for those that do not chose but would have to live near those wind turbines. I have attended many meetings and spoke with many people and have concluded that the lack of safety and the hazards these wind turbines create do not offset the benefits. The hazards these generators impose upon the environment and those that live near them are staggering. To be more specific, I learned at the Columbus township meeting that the Fire Department responsible to address fire related issues with generators of this size would not have the training nor the equipment to put out a fire should one start. The conversation continued with the statement that the Fire Department could only secure the area and allow it to burn out. I learned that because of the materials used to build these wind generators, in the event of a fire, the hazardous potentially fatal fumes created, that a 5-mile radius would be evacuated with no option to stay. How could that type of situation ever be considered "green energy"? We live within ½ of a mile of two proposed sites, should this unthinkable event actually take place where would my family go? Who would take care of my cows, calves and sheep? How long would I have to be gone? Would my animals be forced to die a slow death because I'm not there to feed or water them? Or worse, be exposed to these toxic chemicals whether it be by air or water and then die of an even more gruesome death due to chemical exposure. This is an unthinkable situation to call "green energy." When I asked for further clarification on this no one, including the original power company that contacted me (Columbia Wind), could give me a straight answer and still won't. Another question that I asked that I could not get an honest answer from anyone on was concerning ground water. I have learned that these wind generators can hold anywhere from 500-1,000 gallons of gear lube in the gear boxes between the generator and the propeller. When I asked if these units have oil containment systems, no one would give me a straight honest answer. Since my home and well are in a lower land topography it stands to reason with any level of common sense that this oil or any other hazardous foreign matter produced by these generators would run downhill poisoning my well water which my family and I depend on for life and livelihood. One particular sarcastic individual responded to my question with "well you would just have to buy bottled water." My response to him was are you going to buy me 1,000 gallons of bottled water /day to water my livestock because of someone else's lack of protecting the environment? He did not have an answer for me that was respectful or reasonable. Basically, he admitted without saying so, that this "green energy" that so many people are saying is a wonderful, well thought out plan is not well thought out at all and creates extremely hazardous conditions that right now I do not have to worry about because they are not possible, because the wind generators are not here. Thirdly, no one will answer my question honestly about will I hear this wind generator? Will the power company force me by means of eminent domain to run power cables through my land? I adamantly do not want that. Will my family be imposed upon with transmission cables running through adjoining property or close to my property which would limit or possibly eliminate the potential for my wife and I to build our retirement home on the top of our hill when we retire? I do not understand how our lives and our wishes can be so easily ignored after generations of my family have cared for and preserved this particular piece of land for well over 100 years. If alternative renewable energy is the answer for the future, why can't it be done on an individual basis? I have checked into my own personal solar system which would provide the power that I need, and quite possibly produce an excess which could be sold back to the power company, utilizing the transmission lines that are already in place without disrupting more lives and more of the environment. These are only a few of the many concerns that I have. If I were to list them all this letter would be considerably longer. I believe that with what I have stated that you understand that we are not in support of this project. These big, massive corporate projects are not the answer in my opinion. They give too much power to large corporations to do whatever they want, whenever they want, at the cost of the well-being of the environment and the individuals that live here. My family and I respectfully ask for your support to refuse this type of project which would interrupt the lives of everyone who live here. I further ask that the town of Hampden hire the attorneys who represented the Town of Brighton to protect the environment and people in Hampden township.

The large-scale clearing of land for turbine bases, access roads, and transmission lines fragments ecosystems and displaces native species. Birds and bats are particularly vulnerable - many killed by turbine blades each year, including threatened migratory species. These losses can have a cascading effects on local biodiversity and ecological balance. 2. Soil and Water Impacts - The installation process often involves heavy machinery and deep foundations, which can lead to soil compaction, erosion and runoff. IN agricultural areas like ours, this threatens the integrity of farmland and can contaminate nearby water sources with sediment and construction-related pollutants. These risks are especially concerning in regions with shallow groundwater or sensitive watersheds. 3. Noise and Light Pollution - Wind Turbines generate low-frequency noise and shadow flicker, which can affect both human and animal health. Chronic exposure to these disturbances has been linked to sleep disruption, stress, and behavioral changes in livestock and wildlife. These impacts are not just nuisances-they represent real quality -of-life and economic concerns for rural residents. 4. Visual and Cultural Landscape Degredation - Our rural landscape is not just scenery-It's part of our identity and heritage and our property value is important to our family's financial stability. The towering presence of industrial wind turbines can permanently alter the visual character of our community, diminishing its appeal for residents and visitors alike. This visual intrusion is incompatible with the values and aesthetics of rural living. 5. Limited Local Benefit - Despite the environmental and social costs, the energy generated by these towers often serves distant urban centers, not the local community. Financial benefits tend to accrue to developers and utility companies, while residents bear the burden of environmental degradation and reduced property values. In light of these concerns, we urge decision-makers to reconsider the installation of wind towers in our community. We must prioritize solutions that align with our environmental stewardship, protect our rural way of life, and ensure that the benefits of renewable energy are equitable shared.
